Dhanalkshmi, w/o. P.S. Boopathi Manickam, 15-A, (New No.58) Annes Convent Road, Ponmeni, Madurai-10. Trustees. The following amendments have been made to the Guruji's Educational Trust Deed registered as No. 1101 of 1996 of Book No. 4 Volume 368 Pages 59 to 61 dated 22<sup>nd</sup> May 1996 in the office of Sub-Registrar of Madurai.

**AMENDMENTS**

1. Reserved that the Trust shall be irrevocable.
2. The Trust shall not be run as a commercial institution with an intention to make profits. The assets of the trust shall be solely used for the purpose of giving educational facilities, in such spheres of education as may be decided by the trustees and such facilities shall be established only within India and the benefits of the trust shall extend to all irrespective of caste, community, creed, sex or any discriminatory factors.
3. The term of office of the members of the Board of Trustees shall be for a period of three years except in the case of Dr. C. Chandran and Mr. P.S. Boopathi Manickam who shall hold office till their life time.

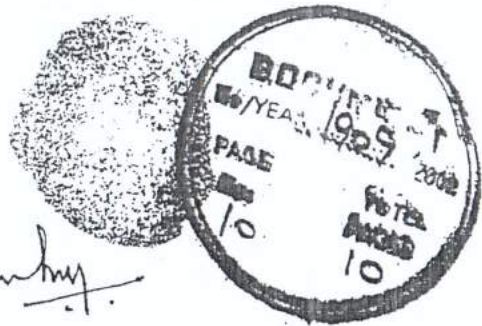

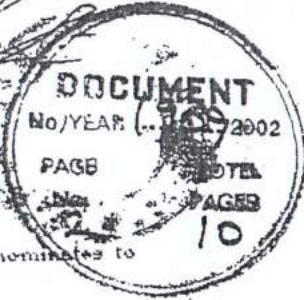

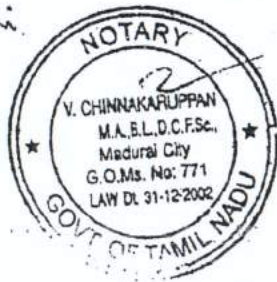
4. The first two trustees shall have the power to appoint their wards/nominees to succeed them as life trustees with mutual consent of life trustees.
5. In the event of resignation by the members of the Board of Trustees before the expiry of the term of office or any vacancy arising due to death or other reason, the resultant vacancy shall be filled up and the person so becoming a member of the Board of Trustees shall hold office from the date of becoming member till the expiry of three years from such date.
6. The Board of Trustees may at any time in their discretion appoint or co-opt one or more trustees. But the maximum number of Trustees to the Board of Trustee shall be seven (7)
7. From among the members of the Board of Trustees Dr. C. Chandran shall be the first secretary and Managing Trustee and shall hold his office as long as he continues to be member of the Board of Trustees. Thiru.P.S.Boopathi Manickam shall be the first Treasurer and shall hold office as long as he continues to be member of the Board of Trustees.
8. The trustees shall be entitled to accept any other sum or sums or movable or immovable property as addition to the Trust from the settlers or from any other person or persons and if additional sums, movable or immovable properties be added to the Trust funds then the trust funds shall mean and include all such additional sums movable or immovable properties thereof the trustees shall hold the same upon the Trust for the beneficiary with the same powers and provisions as are declared herein.

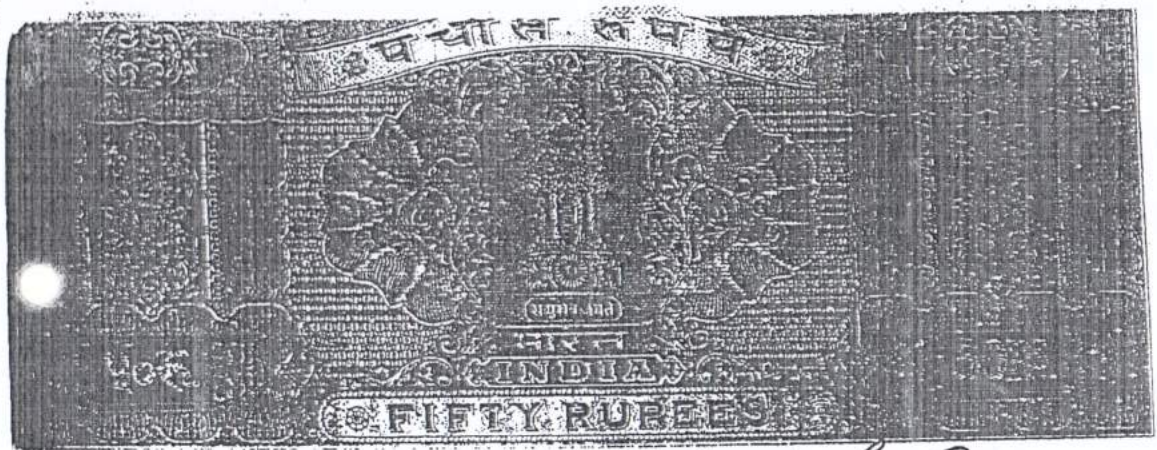

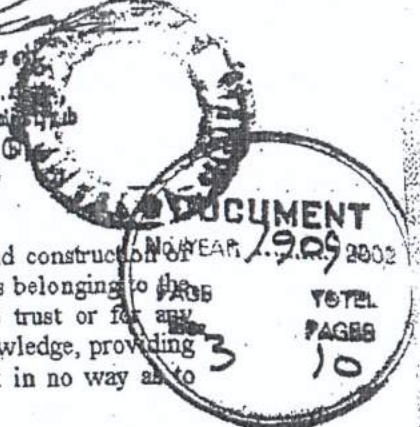

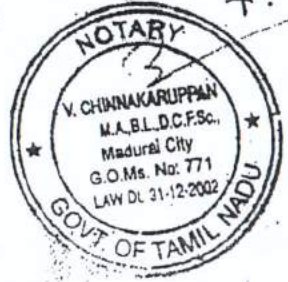
- 9. The trustees may invest the Trust fund either in the purchase and construction of immovable properties with a view to accommodating the students belonging to the Sri Aurobindo Mira Matriculation Hr. Sec. School run by the trust or for any activity relating to the spreading of education, imparting of knowledge, providing hostel facilities to the students of the schools and the like but in no way shall commercialise such activities.
- 10. The Trustees may invest the trust funds in trust name in deposits with scheduled banks or post offices and public financial institutions or in Government securities and shall have power to alter, vary or sell these investments from time to time in such manner as they may in their absolute discretion deem fit, subject to the provisions of Section 11(5) of the Income tax act, 1962.
- 11. The trustees shall hold and stand possessed of the properties both movables and immovables endowed by this indenture and the investments for the time being of the same and/or accumulations, additions, and accretions thereto and/or the investment or conversions of such accumulations, additions and accretions thereto and/or interest, surplus or other income of the Trust fund upon the trust and subject to the powers, provisions, agreements and declaration declared and expressed concerning the same.
- 12. The donations received by the trust shall form part of the corpus fund of the Trust.
- 13. The income of the Trust shall be applied only in pursuit of the realisation of the objects of the Trust.

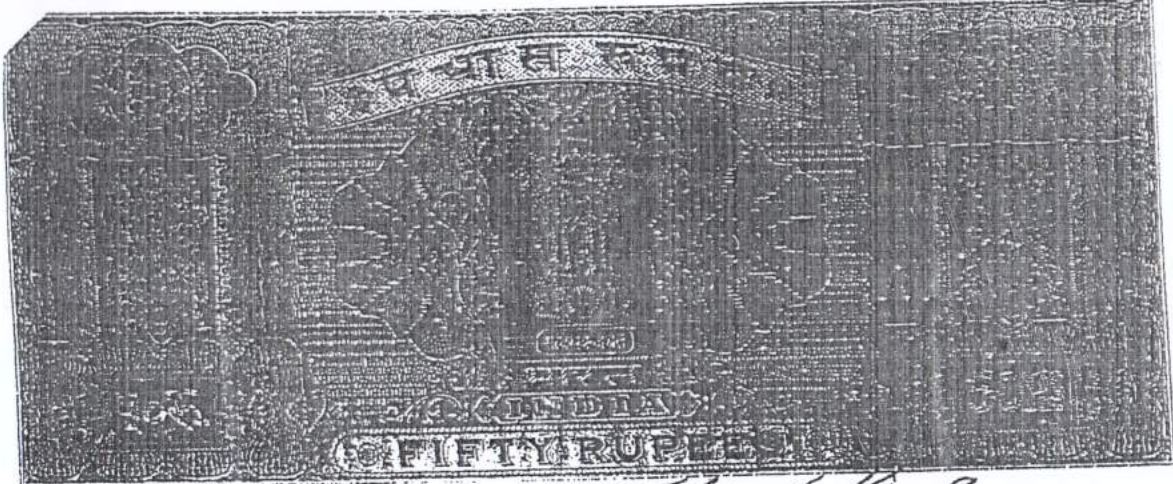

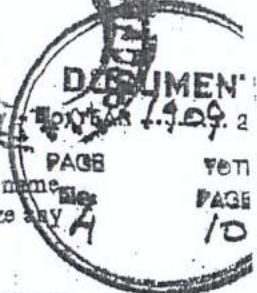

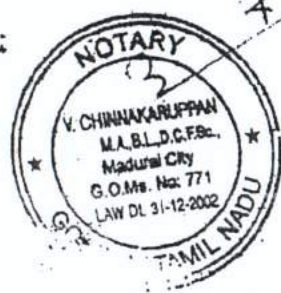
- 14. The Secretary and Treasurer shall from time to time open and maintain in the name of the trust bank account or accounts and shall operate on the same or authorize any one or more of them from time to time to operate the same.
- 15. The Trustees may pay all charges and outgoings payable in respect of any immovable property for the time being forming part of the trust fund and may carry out repairs required to be done to the same and keep the same insured against loss or damage by fire and may incur all other costs, charges and expenses of and accidental to the administration and management of the trust fund and properties for the time being belonging to the trust and in the realisation of the objects of the trust and Trustees may in their absolute discretion think fit and proper.
- 16. The Trustees shall have full power to compromise or compound all actions, suits and other proceedings and all differences and disputes touching the trust fund and/or the trust properties and to refer any such differences or disputes to arbitration and to adjust and settle all accounts relating to the trust fund and/or trust properties and to do all other acts and things as fully and effectually to protect the trust fund and/or properties.
- 17. The trust shall maintain proper books of account and the account of the trust shall be closed once a year on the 31<sup>st</sup> March. The accounts should be checked every year by any authorized Auditor.
- 18. The trustees shall reimburse the member and pay and discharge out of the trust fund all expenses incurred in or about the execution of the trust or any of their dues under these presents.

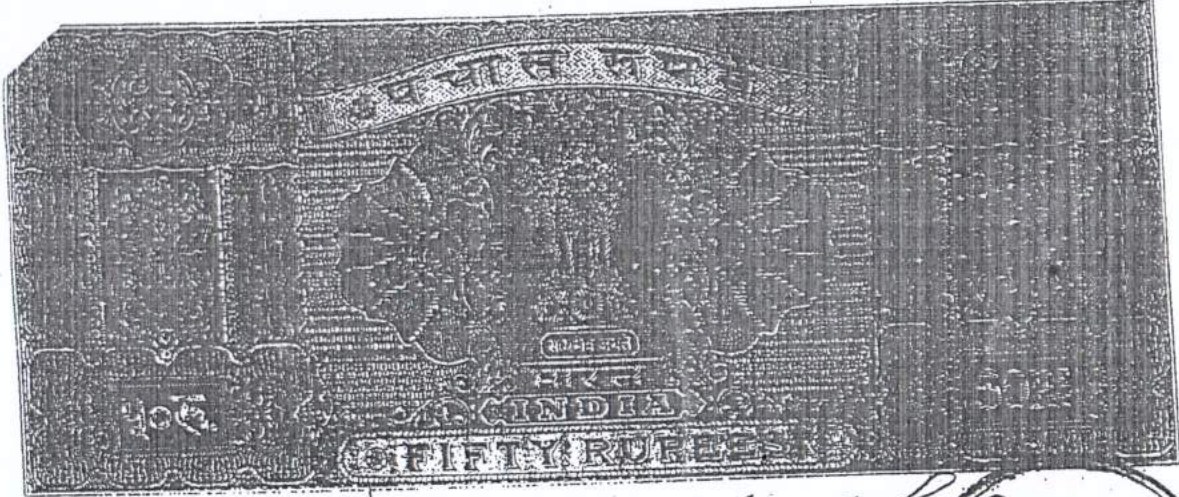
19. The trustees shall not be entitled to monthly remuneration. The Board of trustees shall manage the trust asset and carry on all the affairs of the trust and shall have all the necessary power and authorities for the purpose within the realm of the attainment of the objects of the Trust.
20. In case of differences of opinion among the trustees the opinion of the majority of the trustees shall prevail.
21. The receipts of the Treasurer or Managing trustee and Secretary for any moneys, funds, securities or investments paid, delivered or transferred to the trust in execution of the trust and power hereof shall effectually release and discharge the person or persons paying, delivering or transferring the same.
22. No trustee can delegate any power, duty or authority assigned to him/her. Likewise no trustee is empowered to nominate any person to act on his/her behalf during his/her temporary absence.
23. The trustees may regulate the meetings and proceedings and conduct of duties as they may decide. The proceedings of the meeting shall be entered into a minute book to be kept for this purpose and shall be signed by the majority members.
24. The quorum for a meeting of the Board of Trustees shall be 2/3<sup>rd</sup> of the total members of the Board holding office at the time of meeting, any fraction being treated as one and in any case shall not be less than two and at least two of whom shall be life members of the Board of Trustees physically present as long as the member of life members constituting the Board of Trustees is not less than two.

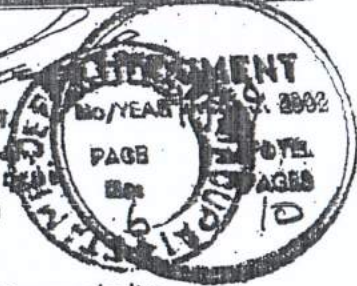

25. A resolution in writing circulated amongst all the trustees and passed by a majority of the trustees shall be as valid and effectually as it has been passed at a meeting of the trustees duly called and convened.

26. Any of the trustees may retire/resign from trusteeship if he/she so desires.

27. The power to appoint a new or additional trustee but so as not to exceed the maximum fixed herein and to fill vacancy in the office of the trustees shall vest in the continuing trustees.

28. On a new trustee being appointed and on his signing the minute book to the effect of his taking possession of the trust fund shall vest to him along with other trustees for the time being and he will be entitled to carry out the duties and functions of trustees.

29. The Managing trustee or Secretary or Treasurer may accept gifts, donations, grants, subsidy and other gratuities, payments from any person or persons for the purpose of the trust upon such terms and conditions as they may deem fit.

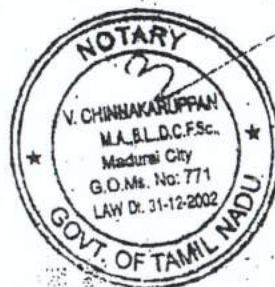
30. The Secretary alone shall be the Correspondent of the Institutes and schools run by the trust. He shall alone have power to make appointments of both teaching and non-teaching staff to the Institutions and schools run by the trust in consultation with life trustees. The power of admission and dismissal of students and staff of the institutes and schools of the trust shall also vest with the trustees.

31. The Managing trustee shall have power to dismiss or otherwise remove any of the teaching and non-teaching staff of the institute and schools on disciplinary grounds or otherwise after providing for an opportunity for such staff and if so required institute an enquiry committee consisting of the board of trustees and members of teaching staff of school and on the recommendation of the committee who shall conduct the enquiry and forward its report within 7 days of the conclusion of the enquiry.

32. It shall be lawful for the trustees:

- a) To apply to the Government, Public bodies including Banks, urban local municipal, district and other bodies, corporation, companies or persons for and to accept grant of money and of aid donations, gifts, subscriptions and other assistance with a view to promoting the objects of the trust and to discuss and negotiate with the Government Department public and other bodies, corporations, companies or persons, scheme and other work and matters within the objects of the trust and to conform to any proper condition upon which such grants and other payments may be made.
- b) To take over or amalgamate any other charitable trust, society, association or institution with similar objects.
- c) To establish, promote, manage, organise or maintain or assist in establishing, promoting, managing, organizing or maintaining any branch of trust or any other trust or its branch with objects similar to those of this trust and to promote or carry on the affiliation or amalgamation of such other trust with this trust.
- d) To take over, acquire, manage, control or aid any existing institution or institutions having object either wholly or in part similar to these objects of this trust and on such terms and conditions as may be thought expedient.
- e) To purchase or otherwise acquire and undertake all or any part of the property, assets, liabilities and engagement of any or more of the trust societies, Institutions or Associations with which this trust is authorized to amalgamate.

33. In general the following expressions used in this indenture shall have the meaning assigned to it as set out hereunder :

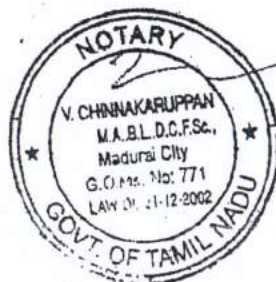

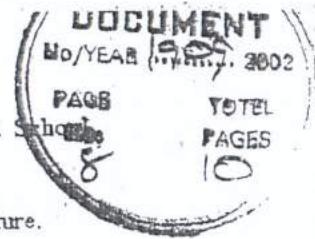

- c) The term 'schools' means, Sri Aurobindo Mira Matriculation Hr. Sec. School, 108, Nehru Nagar, Bye-pass Road, Madurai-10.
- d) The term 'Trust' means Guruji's Educational Trust created by this indenture.
- e) Expressions or words imparting masculine gender shall include the feminine gender and vice versa.
- f) Words imparting the singular shall include the plural and vice versa.
34. It is expressly declared that no part of the Trust property or its income shall be applied for any purpose outside India or for any purpose other than the one for which the Trust is established.
35. The Board of trustees shall have full power to nominate any trustee and run the Trust as per Rules, clauses, regulations and Bye-laws. Such succeeding nominated trustees shall hold his office till his life time.
36. The Board of trustees have full powers to encumber the assets of this trust to develop the institution/s run by the trust. No other member of the trust has powers to encumber any property of this trust, movable or immovable on any circumstances.
37. The Board of trustees shall have powers to dismiss or remove any member of this trust whose activities are proved to be prejudicial to the object of Trust by 3/4 majority except first four Trustees/Ensuing Life Trustees framed in this deed.
38. The Board of Trustees should maintain Register for furniture, library books, science apparatus, show case things electrical and electronic equipments and other materials belong to Institutions and other relevant accounts records.
39. During the temporary absence of the Secretary, the Treasurer will look after the day-to-day affairs.
40. The Trustee should maintain a minute book. All proceedings and transactions must be entered in the minute book, passed or approved and signed by the Chairman and Trustees.
41. The trust shall not transfer the assets to any individual or any other person except to a trust/ charitable institution established for similar purposes, if the trust is dissolved at any time in the future. The trust shall not make any payments to any trustee/ members/office bearers in form of dividend/ profits or interest etc.

The trust during its existence shall utilize its income solely for the purpose of achieving the objects of the trust and shall not utilize any portion of it for payment to the trustees/members/office-bearers by way of profit/dividend/interest, etc.

The Clause 42 of the trust deed shall read as follows:

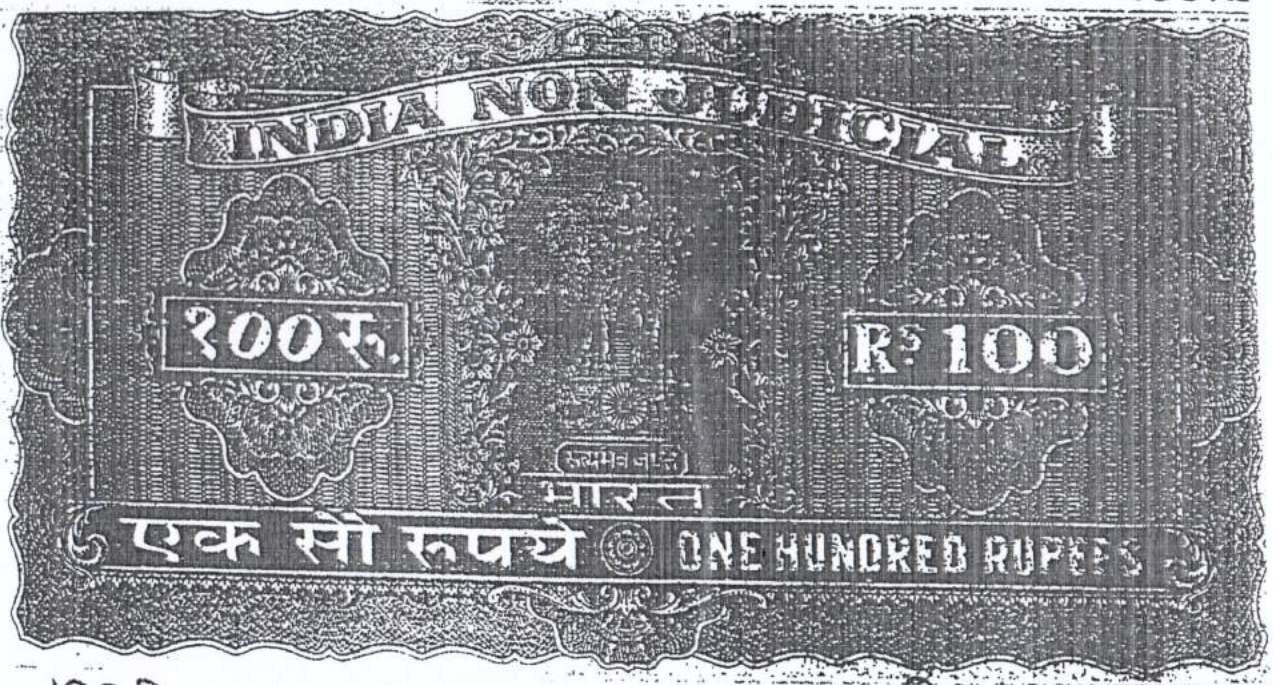
